



## FOLEY LIMITED Health and Safety Policy Statement

The objectives of FOLEY LTD Health and Safety Policy is to prevent, insofar as it is reasonably practicable to do so, during the course of the work or duties being undertaken, any accidental occurrence resulting in:

- Injury to any person.
- Damage to, or loss of any plant, equipment, property, materials or products.
- Delays in any processes or operation.
- Events that may otherwise be detrimental to efficiency and/or prestige.
- Adverse impact upon the environment.

### OVERALL RESPONSIBILITY ARRANGEMENTS:

**The Overall Control and Management of the Policy is the responsibility of MR JOHN FOLEY MANAGING DIRECTOR OF FOLEY LTD hereafter referred to as FOLEY LTD and is the Named SAFETY DIRECTOR**

Although duties and tasks may be delegated, the overall responsibility remains with John Foley to ensure that the Company complies with all relevant statutory health and safety legislation, common law and Approved Codes of Practice and other codes of practise-associated with the business.

### FUNDING ARRANGEMENTS

To ensure that this Policy is successfully implemented, FOLEY LTD and its Board of Directors shall provide such funds as is reasonably necessary under the responsibility of Terry Foley Finance Director.

### OTHER SAFEGUARDS ARRANGEMENTS

Suitable and adequate measures shall be taken to safeguard any person, plant, equipment, property, material or product likely to be exposed to any known or suspected hazards associated with or arising out of the processes, tasks or operations being undertaken.

FOLEY LTD Senior Management shall take into account at tendering stage, those factors which assist in eliminating injury, damage and waste.

### TRAINING ARRANGEMENTS:

Where necessary FOLEY LTD Employees shall have the competency and skills associated with their Profession--Trade or other suitable qualifications, also shall be suitably trained or instructed to enable them to carry out their tasks in a healthy, safe and efficient manner.

### WELFARE PROVISION ARRANGEMENTS:

Adequate provision shall be made for the Welfare needs of Employees whilst carrying out their tasks and duties and any hazard to health associated with the work shall be the subject of strict precautionary measures.

This is further detailed within Section Two of the Health and Safety Policy.

### AUDIT-MONITORING & REVIEW ARRANGEMENTS

All related matters under these arrangements shall be under the direct Management Supervision of JOHN FOLEY
